LEGAL DISCLAIMER REGARDING COVID

Out of respect to our authors, guests, volunteers, vendors, and hotel staff, all attendees will be required to submit documentation that they have received a full COVID-19 vaccination prior to attending the Festival. We will contact attendees in early summer with instructions about how to deliver the requested proof. For attendees with objections to vaccinations, we will accept evidence of a negative PCR test (not rapid test), taken not more than 96 hours before arriving at the Festival, to be delivered prior to arrival.

Please note that Sonoma Valley Authors Festival passes are nonrefundable under any circumstances. No refunds will be given to Festival Pass Holders who are unable to attend because they have not been vaccinated or are unable to take a PCR test 96 hours before arriving at the Festival. If we have a waiting list, we may attempt to find buyers for the Festival Pass Holders who are unable to attend. This offer is by no means guaranteed, so please do not rely on the possibility that you will be reimbursed.
